### TUITION AND FEES

### FINANCIAL AID

If I am eligible for the Virginia Education Tax Credit Program (VETCP) for the 2020-2021 school year, I understand that any monies received by RTA from the VETCP will be applied as a credit to my full tuition amount. I understand that after such application of the VETCP that I may still owe a balance for tuition. I understand that further financial aid may be granted by the scholarship committee to offset some or all of the balance due. In applying for VETCP scholarship(s), I agree to submit all necessary documentation to FACTS, via its online process, by July 1, 2020, and I allow RTA to submit my financial documents to the agency responsible for the funding of the scholarships.

### CANCELLATION AND EARLY WITHDRAWAL

You may cancel this Enrollment Contract without penalty (except forfeit of the Reservation Deposit) by providing written notice to RTA on or before August 1, 2020. Any costs incurred by RTA will be deducted from the refund.

If enrollment is canceled after August 1, 2020 parents or guardians financially responsible for the student(s) are obligated to pay the full annual charges as set forth in this Enrollment Contract.

Your obligation to pay the tuition and fees for the full academic year is unconditional. After August 1, 2020 no portion of tuition and fees paid or outstanding will be refunded or canceled in the event of absence, withdrawal or dismissal from the school of the above student(s).

### PARENTAL PARTICIPATION

I understand that my participation in school activities is an integral part of the education of my child(ren), as well as the ongoing functioning of RTA. I therefore agree to both of the following:

2. I agree to release and hold harmless RTA, its agents and employees, from all claims, damages or other liabilities for injuries to my child which are not the result of gross negligence by RTA, its agents or employees.
3. I agree to indemnify RTA for damages caused by my child(ren). I give permission for my child(ren) to attend all school sponsored trips and activities.
4. I understand and agree with RTA's policy that the above-referenced students' grades and transcripts will not be released unless my account has been paid in full and all Give or Get requirements have been met.
5. I grant RTA permission to use and release photographs and other images of my child/children in RTA-related promotional materials, marketing efforts, social media, and productions without restriction. This release applies to all images of my child/children in print, electronic, video and broadcast formats.
6. I understand that RTA shall have the right to pursue legal action for collection of school tuition and fees, and that I will be responsible for all costs of collection, including court expenses and reasonable attorney's fees.
7. No amendment to this Enrollment Contract will be effective unless it is in writing and signed by both RTA and me.
8. This Enrollment Contract shall be interpreted in accordance with the laws of the Commonwealth of Virginia. In order to reserve a place for your child(ren), for 2020-2021, this Enrollment Contract and your Reservation Deposit must be received by the school no later than April 1, 2020.
